Dogs may be entered in any jump height. There is no Regular or Preferred distinction at AKC's ACT events.

In order to acquire the ACT1 or ACT2 title certificate and have the title added to a dog's record, the dog must be registered/listed with the American Kennel Club. AKC Canine Partners<sup>™</sup> applications may be accepted at the event and submitted to AKC with the event's results.

Dogs that are not AKC registered/listed may be registered at a later date and receive theirACT title at that time.

Dogs listed in the **AKC Canine Partners**™ program should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler Number on the front of this form. Should you not have Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
